Subject: Guidelines for "Celebration of India's G20 Presidency- Leveraging Neighbourhood Youth Parliament at District level"- regarding;

Madam/Sir

This is in reference to this office letter no. Ref. No. NYKS/Prog: NYP/2022-23/282 dated 20.12.2022 vide which implementation of Neighbourhood Youth Parliament 2022-23 was put on halt.

Now as per approval of competent authority, updated guidelines of NYP by integrating the components of G-20 have been prepared and placed at **Annexure-1** for information and needful please.

In view of the significance that G20 holds for the nation, during this year, NYKS plans to leverage District level NYPs to amplify the significance of the event, reinforce national pride and spearhead initiatives to showcase the rich cultural mosaic and various developments in the respective districts through the platform of NYP. To accomplish these goals by putting Youth at the Centre, the following are decided:

- **Theme:** "Vasudhaiva Kutumbakam- One Earth, One Family, One Future"
- **Sessions** - Dedicated sessions are to be conducted on the Importance of G20 Presidency, Y20 Youth Summit along with the Mission LiFE, International Year of Millets as highlighted by Hon'ble Prime Minister.
- **'Atithi Devo Bhava'**- 1-hour Cultural Performance at the end of NYPs showcasing the unique culture of the district.
- **Branding of G20 and Y20** -In all banners, standees, resource material, etc., the logo of G20 along with official photos of Hon'ble Prime Minister and Hon'ble Minister of Youth Affairs and Sports are to be prominently displayed.

The funds are being released soon by this office. It is expected that the programme will be organised in a befitting manner in all the 763 Districts as per the timeline (25th January 2023- 28th February 2023).

The State Directors are required to share the guidelines and pre-event reporting proforma with all DDs/DYOs on immediate basis and ensure that the **pre-event report is filled in by 19th January 2023.**

Both Deputy Directors and District Youth Officers may also visit the Govt. of India Website of G-20 for better understanding of the issue. The Resource Persons should be identified carefully and someone who may be possessing adequate knowledge on G-20. A pre-programme briefing to the Resource Persons and moderators will make them well equipped with the requisite skills and know-how on the issue of NYP.

It is the overall responsibility of the State Directors to ensure that the all District level NYPs are organised strictly as per the enclosed guidelines, by ensuring participation from all blocks of the Districts, VIP participation and enhanced visibility.
