OFFICE ORDER

Sub: **Pay Revision of employees of NYKS in pursuance to the acceptance of Seventh Pay Commission recommendations by the Government-reg.**

Ref: **F.No.A-26011/2017-NYKS dated 24.05.2017 of Ministry of Youth Affairs & Sports**

In pursuance to the OM F.No.1/1/2016-E.III(A) dated 13th January, 2017 of the Government of India, Ministry of Finance, Department of Expenditure regarding Guidelines for Pay Revision of employees of Quasi-Government Organisations, Autonomous Organisations, Statutory Bodies etc. set up by and funded/controlled by the Central Government, read with Notification dated 25.07.2016 of Ministry of Finance Department of Expenditure regarding Central Civil Services (Revised Pay) Rules, 2016 and the OM No.1-5/2016-IC dated 29.07.2016 of the Ministry of Finance, Department of Expenditure (Implementation Cell, 7th CPC) and other related instructions of the subject and to state that the Ministry of Youth Affairs & Sports, Government of India has approved the extension of Pay Revision benefits to NYKS employees as per the Seventh Pay Commission recommendations as accepted by the Government, subject to the following conditions. Board of Governors, NYKS had earlier recommended for 7th CPC Pay to Sangathan employees in the meeting held on 21.09.2016.

- The revised pay structure shall be admissible to those employees who opt for the same in accordance with the extant Rules.
- Deductions on account of Provident Fund, Contributory Provident Fund or National Pension System, as may be applicable, will have to be made on the basis on the revised pay w.e.f. the date an employee opts to elect the revised pay structure.
- The fixation of revised pay shall be subject to post audit and any other examination by the Government of India in terms of rules/regulations governing pay/allowances to such categories of employees of the Central Government and if any excess payment comes to notice during the course of such examination/audit, the same shall be recovered forthwith.

- d) This approval is only for Revision of Pay in terms of provisions of the Central Civil Services (Revised Pay) Rules, 2016 and other instructions on the subject, as the OM dated 13.01.2017 of the Ministry of Finance, with respect to autonomous bodies, relates to Pay Revision only. This does not cover revision of allowances or pensions, as the Government of India is yet to issue instructions in that regard.
- e) The incremental expenditure on account of revision of pay (including payment of arrears) shall be met out of funds available with NYKS (including interest income) and the block grants being released from time to time, in a manner that the implementation of the programme is not hampered.

All terms and conditions shall remain as laid down in F.No.A-26011/1/2017-NYKS dated 24.05.2017 of Ministry of Youth Affairs & Sports.
