Interested Parties may submit their highest price for the items displayed in a sealed cover latest by 03:00 PM on or before 15-05-2019. The quotation and DD/Pay Order/Banker's Cheque towards EMD may be dropped in the Tender Box kept at the Reception of the NEHUR YUVA KENDRA SANGATHAN, Main G.T. Road, Alipur, Delhi. The outer cover should be super scribed in Bold Capital Letters "QUOTATIONS FOR AUCTION OF CONDEMNED ITEMS.

1. The disposal of items shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or certificate of its worthiness or quality will be given by this office. The condition of the items can be inspected physically between 11.00 AM to 4:00 PM on 14-05-2019 at Nehru Yuva Kendra Sangathan, Main G.T. Road, Alipur, Delhi.
2. The quotation should be accompanied by earnest money for Rs.25,000/-. The earnest money can be deposited by Bank Draft/DD/Banker Cheque in favour of Nehru Yuva Kendra Sangathan, Delhi. The bank draft should be attached with the quotation letter failing which the quotation shall not be considered at all. If the highest bidder/successful tenderer accepted by the competent authority in this office fails to deposit the quoted by the next day, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.

3. The successful bidder/bidders will be required to deposit the total bid amount by means of Demand Draft/Pay Order/Banker/s Cheque in favour of Nehru Yuva Kendra Sangathan, Delhi.
