**Subject:- Initiating Selection Process of NYVs as per Revised Guidelines. Reg..**

Sir/ Madam,

With reference to the above, I am directed to inform you that the Competent Authority in the Ministry of YA&S has directed that as considerable time has lapsed since the last advertisement, immediate necessary steps for putting up the advertisement for selection of NYVs needs to be taken up. Accordingly, the selection process of NYVs initiated vide NYKS letter dated 22.02.2018 and 07<sup>th</sup> June, 2018 stands cancelled.

2. In view of the above, I am directed to inform you that the NYV selection process initiated earlier vide NYKS letter dated 22/02/2018 and 07/06/2018 stands cancelled and fresh advertisement for inviting applications for selection of NYVs may be issued as per the revised guidelines (as on 12.02.2019) for selection of NYVs (**Annexure -1**).

3. All State Directors are requested to direct all concerned DYCs to issue fresh advertisement in local leading newspaper (in local language) as per the time schedule given in the enclosed revised guidelines (as on 12.02.209) for selection of NYVs. Rs. 5000/- each district for release of advertisement (**as per approved specimen copy of advertisement enclosed Annexure -2**) should be released at the earliest. For this purpose, DYCs are permitted to use the available fund at the Kendra level. SDs are requested to monitor district wise progress on day today basis. Time line should be adhered as the deployment process takes minimum required time.


4. As the earlier selection process is cancelled, all eligible applicants who had earlier applied for NYV selection needs to re-apply against the new advertisement which to be issued by respective DYCs.

5. List of members for nomination to NYV selection committee as per the revised guidelines will be forwarded separately for necessary action.
