Subject : Conduct of Youth Parliament Festival at District, State and National Level, 2022-regarding.

This has reference to communication from Deptt. of Youth Affairs, Ministry of Youth Affairs vide which it has been communicated that like previous year, Youth Parliament Festival will be organized at District, State and National Level between 14th February 2022 to 9th March 2022.

2. It has been decided that to conduct Youth Parliament Festival, 2022 at District, State and National Level as per the following time line:

| Level | Dates |
|----------|---|
| District | 14 th February 2022 - 19 February 2022 |
| State | 23 rd February 2022 - 27 th February 2022 |
| National | 8 th March 2022 - 9 th March 2022 |

3. *It may please be noted that Youth Parliament Festival is different from ongoing District level Neighbourhood Youth Parliaments.*
4. **Guidelines:** In order to conduct Youth Parliaments at District and State Level in a smooth manner through **VIRTUAL MODE**; a detailed Guidelines received from Ministry are enclosed. This should be shared among Deputy Directors and District Youth Officers immediately and with the direction that contents of guidelines should be read carefully for time bound compliance. In the Guidelines, the components like *objective of the programmes, criteria for participation, timeline, selection process at District, State and National Level, evaluation criteria, language, topics for competition, time for speech etc* have been included.
5. For conducting District Level Youth Parliaments, 150 specified Nodal Districts have been identified in which 623 District NYKs as well as 125 Non-NYK Districts=748 districts would participate. A list of specified 150 Venue Districts and participating 748 districts are given in Annexure-1 of the enclosed Guidelines.

6. **Participation:** Youth to participate in Youth Parliament must be **above 15 and less than 29** years of age as on **13th February 2022**. Maximum youth from all sections of the society and women should be motivated to participate in the District Youth Parliament. District Youth Officers should coordinate with NSS Regional Directors and Programme Officers for participation of their volunteers in District Youth Parliaments.
7. **Topics for Discussions:** The list of the topics is **enclosed at Annexure-II**. The topics for discussion at different levels should be released as per following time line.
- i. Topics for DYP- 13th February 2022
 - ii. Topics for SYP -22nd February 2022
 - iii. Topics for NYP-7th March2022
8. **Time for Speech :**Four (4) minutes time will be given to each participate to speak on the given topic at the District and State level Youth Parliaments.
9. **Registration:** For enrolment of the participants, a **Registration Form is enclosed**. Each of the participant will have to provide self attested photocopy of the following:
- a) Any Government document viz., domicile certificate, driving license, voter ID, Aadhar Card etc which verify that participant belongs to a particular districts.
 - b) Passport size photograph to be affixed on Registration Form.
 - c) Date of Birth Certificate
 - d) The Registration Form should be verified by concerned District Youth Officer of District NYK and NSS RD/PO as the case may be.
10. **Recognition:** 1st and 2nd ranked/winner youth should be selected from each of the Districts. The 1st and 2nd ranked/winner youth would participate in State level competition. Similarly, the 1st, 2nd and 3rd Prize ranked youth would participate in National Level Youth Parliament . More details are given in the **enclosed Guidelines**.
11. **Legal:** Any dispute w.r.t Selection of best youth for participation at District and State Level, the decision of NYS would be final and binding.
12. **Widely circulate:** The above programme details among NYVs, Members of Youth Clubs, COVID Volunteers, Education Institutions, Universities and others through Mobiles, Phone. Social Media Platforms like WhatsApp, Facebook, Twitter, e-mails and others. Motivate them to participate and circulate among their peers, villagers and other stake holders.

- ✓ Before and after the event, adequate coverage in both Printing and Electronic Media should be ensured.
- ✓ Social Media Platform should be used.
- ✓ Activities Photographs, videos and press clippings should be sent to NYKSHQr: coreprogrammenyks@gmail.com through whatsapp and email.

14. Reporting: State Directors should submit the following to NYKS HQr on: coreprogrammenyks@gmail.com

- Details of participants (both NYKS & NSS) took part in District Youth Parliaments (Annexure-3 & 3A) by 19th February 2022.
- Details of 1st and 2nd Winners of District Level Youth Parliaments (Annexure-4 & 4A) by 19th February 2022.
- Details of 1st and 2nd Winners of State Level Youth Parliaments (Annexure-5) by 27th February 2022.
- Details of Winners of State Level Youth Parliament along with original Registration Form should be submitted to NYKS HQr by 27th February 2022. The Registration Form should be duly verified.

15. While conducting Youth Parliaments of District and State Level, COVID-19 safety advisories and guidelines issued by the Government and District Administration should be followed.
