Subject : Conduct of Youth Parliaments at District, State and National Level between 23rd December, 2020 to 13th January, 2021-regarding

1. This has reference to the letter of even number dated 21st December, 2020 of Director (YA-NSS), MoYAS vide which it has been communicated that Like previous year, National Youth Parliament Festival will be organized at District, State and National level between 23rd December, 2020 to 13th January, 2021.
2. It has been decided that as a part of National Youth Festival, 2021, Youth Parliaments at District, State and National Level would be organized as per the following timeline:

Level	Dates	Venues
Launch of National Youth Parliament Festival, 2021	23 rd December, 2020	Through Virtual Mode
District	24 th to 29 th December, 2020	Venue Districts – Virtual Mode
State	1 st to 5 th January, 2021	State Capitals – Virtual Mode
National	12 th & 13 th January, 2021	Central Hall, Sansad Bhawan, New Delhi

3. For conducting district level Youth Parliaments, **100 Venue Districts** have been identified in which 623 Districts NYKs as well as 100 Non-NYK Districts would participate. A **list of the Venue Districts and participating districts** provided by you is **enclosed** at Annexure- 1.
4. **Guidelines** - In order to conduct Youth Parliaments at District and State level in a smooth manner through **VIRTUAL MODE**, **detailed Guidelines** received from Ministry are **enclosed**. In the guidelines, the components like **objective of the programme, criteria for participation, timeline, selection process at District, State and National level, evaluation criteria, language, topics for competition, time for speech, etc.** have been included.
5. **Participation:** Youth, to participate in Youth Parliament must be above 18 and less than 25 years of age as on **30th November, 2020**. Maximum youth from all sections of the society and women should motivated to participate in the District Youth Parliament. District Youth Officers should coordinate with NSS, Regional Director and Programme Officers for participation of their volunteers in District Youth Parliaments.

6. **Topics for Discussion :** The list of the topics is **enclosed** at **Annexure-2**. The topics for discussion at different levels **should be released as per following time line:**
- Topics for DYP: 22nd December, 2020
 - Topics for SYP: 31st December, 2020
 - Topics for NYP: 10th January, 2020
7. **Time for Speech:** Four (4) minutes time will be given to each participant to speak on the given topic at the District and State level Youth Parliaments.
8. **Registration:** For enrolment of the participants, a **Registration Form** is **enclosed**. Each of the participant will have to provide self attested photocopy of the following:
- Any Government document viz. domicile certificate, driving license, voter ID, Aadhar Card, etc which verify that the participant belongs to that particular districts.
 - Passport size photograph to be affixed on Registration Form.
 - Date of Birth Certificate
 - The Registration Form should be verified by concerned District Youth Officer of District NYK, NSS RD/ PO as the case may be.
9. **Awards and Recognition :** 1st and 2nd ranked / winner youth should be selected from each of the Districts. The 1st and 2nd ranked / winner youth would participate in State level competition. Similarly, the 1st , 2nd and 3rd prize ranked youth would participate in National Level Youth Parliament. More details are given in **the enclosed Guidelines**.
10. **Legal:** Any dispute w.r.t. Selection of best youth for participation at District and State level, the decision of NYKS would be final and binding.
11. **Widely circulate** the above programme details among NYVs, members of Youth Clubs, COVID volunteers, Education Institutes, Universities and others through Mobiles, Phone, Social Media Platform like, Whats App, Facebook, Twitter, e-mails and others. Motivate them to participate and **circulate** among their peers, villagers and other stake holders.
12. **Media & Publicity for Visibility**
- ✓ Before and after the event, adequate coverage in both **Printing and Electronic Media** should be ensured.
 - ✓ **Social Media Platform** should be used.
 - ✓ Activities photographs, videos and press clippings should be sent to NYKS Hqr: mpsharmanyak@yahoo.co.in through Whats App and e-mail.
 - ✓ **Sample Poster on District Level Youth Parliament** is **enclosed** for adaptation and publicity.

13. **Reporting** – State Directors should submit the following to NYKS Hqr. : mpsharmanyks@yahoo.co.in

- Details of participants (both NYKS & NSS) took part in District Youth Parliaments (**Annexure-3 & 3 A**) by **29th December, 2020**
- Details of 1st and 2nd Winners of District Level Youth Parliaments (**Annexure- 4 & 4A**) by **29th December, 2020**
- Details of 1st and 2nd Winners of State Level Youth Parliaments (**Annexure-5**) by **5th January, 2021**
- Details of winners of State level Youth Parliament along with **Original Registration Form** should be submitted to NYKS Hqr. by **5th January, 2021**. The Registration Form should duly be verified.

14. While conducting Youth Parliaments at District and State level, COVID 19 safety advisories and Guidelines issued by Government and District Administration **should be followed**.
