- 1. Please refer to the discussion and directions of DG given during the meeting held on 29.11.2016 at Vishwa Yuvak Kendra, Chanakyapuri, New Delhi regarding Youth mobilization and participation in Awareness & Education on My Mobile....My Bank....My Wallet among masses.
- 2. In this connection you are requested to ask DYCs under your jurisdiction to conduct following activities for using Mobile phone for transaction without cash through different methods viz. United Payments Interface (UPI), Unstructured Supplementary Service Data (USSD), e-Wallet, Cards, Point of Sale (POS), Aadhar Enabled Payment System.
  - Make aware and educate NYV in a session
  - Motivate trained NYVs to further impart training to the allotted and assigned youth club members and youth
  - Allot / assign responsibilities to NYVs to cover 20-25 villages having NYKs Youth Clubs and groups
  - In each of the allotted villages (20-25) each NYV to contact, organize and train 15-20 youth

- Motivate trained youth (15-20) per village to personally contact 30-35 villagers and shopkeepers and orient them about cashless transaction of money in their day to day transactions
