OFFICE ORDER

WHEREAS orders were issued for closure of offices of NYKS due to lockdown for containment of COVID-19 pandemic in the country.

AND WHEREAS Ministry of Home Affairs, GOI vide order no. 40-3/2020-DM-I(A) dated 15th April, 2020 have issued revised guidelines stating that the lockdown for containment of COVID-19 pandemic will continue to remain in force upto 3rd May, 2020 to contain the spread of COVID-19 in the country.

AND WHEREAS the revised guidelines also states that, to mitigate hardship to the public, select additional activities will be allowed, which will come into effect from 20th April, 2020.

AND WHEREAS point no. 18 of the above guidelines stipulates that "Offices of the Government of India, its Autonomous / Subordinate offices will remain open, as mentioned below :-

- i. Defence, Central Armed Police Forces, Health and Family Welfare, Disaster Management and Early Warning Agencies (IMD, INCOIS, SASE and National Centre of Seismology, CWC), National Informatics Centre (NIC), Food Corporation of India (FCI), NCC, Nehru Yuva Kendras (NYKs) and Customs to function without any restriction.
- ii. Other Ministries and Departments and offices under their control are to function with 100% attendance of Deputy Secretary and levels above that. Remaining officers and staff to attend upto 33% as per requirement.

NOW THEREFORE, in view of above guidelines of the Ministry of Home Affairs, GOI, it has been decided that the district Nehru Yuva Kendras (NYKs), State Offices including PAO offices and Head office of NYKS shall start functioning from 20th April, 2020. It would be mandatory for all the Officers/employees to attend their respective offices without fail.

On opening the offices on 20th April, 2020, all the State Directors shall submit report indicating if any officer/employee who is absconding from services/has not joined duties.

In view of emergency situation and special importance given to Nehru Yuva Kendras, in the above guidelines, it is imperative that all the offices of NYKs should function with full strength w.e.f. 20th April, 2020 by strictly adhering to MHA Guidelines.

A copy of above guidelines (MHA Order No.40-3/2020-DM-1 (A) dt 15/4/2020) issued by Ministry of Home Affairs, Government of India, is annexed herewith for strict compliance.
