**Sub: Revision of Dearness Allowance, HRA and NPS – reg.**

Madam/ Sir,

The Competent Authority has allowed enhancement of Dearness Allowance (DA) to employees of NYKS from existing rate of 28% to 31% of the basic pay w.e.f. 01st July 2021. This is in compliance of Ministry of Finance OM NO. 1/4/2021-E-II (B) dated 25.10.2021 and approval of the Ministry of Youth Affairs & Sports vides F.No. 1-18/2016-NYKS dated 01.11.2021. Revised rate of DA may be released from Salary of January 2022. Arrears of DA from July 2021 to December 2021 shall be paid on receipt of additional grant for the same from the Ministry in due course.

In accordance to point 3 of the Ministry of Finance OM No. 2/5/2017-E.II(B) dated 07.7.2017 and F. NO. 1/2/2016-E-III(A) dated 26.07.2017 and approval of the Ministry of YA&S vide letter No. 1-18/2016-NYKS (pt file) dated 05.11.2021, the Competent Authority has also allowed enhancement of HRA from existing rate of 24%, 16% and 8% for X,Y and Z class of cities to 27%, 18% and 9% for X,Y and Z class of cities respectively w.e.f. 1st July 2021. Revised rate of HRA may be released from Salary of January 2022 and arrears from July 2021 to December 2021 shall be paid on receipt of additional grant for the same from the Ministry in due course.

The Competent Authority also allowed enhancement of employer contribution on NPS from exiting 10% to 14% as approved by the Ministry of YA&S vide letter No. 1-51/2015-NYKS dated 27.10.2021. NPS subscription from January 2022 may be remitted as per revised rate. Difference of NPS remittable for previous period shall be calculated and remitted before close of financial year on receipt of additional grant.
