

- The above fixation of pay on account of grant of benefit under MACP scheme is subject to post-audit and any other examination by the Government of India in terms of rules/regulations governing pay/allowances of the employees of Autonomous Body.
- The pay fixation of above officials has been calculated from the available records at Headquarters. State directors of concerned PAOs are requested to re-check the fixation and ensure correctness of pay fixation before releasing monthly salary/arrears. The entry of pay fixation should be made in the respective service books.



4. The State Directors are also requested to ensure that rules relating to annual increment are followed i.e., annual increment on date of next increment is subject to fulfilling minimum required six months service. Thus the presence of employees on date of the annual increment is to be ensured, as per rule.
5. In 7<sup>th</sup> CPC regime, there are two dates of increments i.e., 1<sup>st</sup> January and 1<sup>st</sup> July in contrary to 6<sup>th</sup> CPC regime when the annual increment was admissible uniformly on 1<sup>st</sup> July every year. Rule states that "Increment in respect of an employee appointed/promoted or granted financial upgradation during the period between 2<sup>nd</sup> day of January and 1<sup>st</sup> day of July (both inclusive) shall be granted on 1<sup>st</sup> day of January and the increment in respect of an employee appointed/promoted or granted financial upgradation during the period between 2<sup>nd</sup> day of July to 1<sup>st</sup> day of January (both inclusive) shall be granted on 1<sup>st</sup> day of July."
6. All State Directors are requested to ensure that all employees furnish the declaration/undertaking to the effect that any access payment made out of this pay fixation will be recovered from them without any notice.
7. Format of undertaking is enclosed at Annexure-A.
8. All the officials are entitled to draw arrears, if any, as mentioned in the above table.
