

As aware the IDY Programmes are to be organized on 21st June, 2015 from 7:00 a.m. to 7:35 a.m.

During the meeting held on 28th May, 2015 under the Chairmanship of Secretary (Youth Affairs), MoYAS, it was informed by Secretary that Hon'ble Prime Minister of India while reviewing the preparedness for celebrating the International Day of Yoga enquired that how the NYKS is observing the IDY on 21st June, 2015. In response, Secretary (Youth Affairs) explained that NYKS would celebrate the Day at District and Village level across the country with the participation of NYKs affiliated Youth Clubs and Mahila Mandals. Therefore, the plan of implementation of the IDY by NYKS needs to be concretized.

in the above context, the matter was submitted through a note and discussed with Director General over phone vesterday, whereby the current manpower availability with NYKS, ongoing Punarjagaran Yatra in 40 districts, NYCs selection process, other Ministries funded projects, etc were brought forward in the knowledge of Director General.

In view of the above, Director General desired to know the extent to which NYKS can actually organize IDY 2015 activities with visibility and quality programmes at district and village level across the country as well as Block Level Neighbourhood Youth Parliaments from 10th to 19th June, 2015. Director General has indicated that the will personally look into the position.
