<u>Circular</u>

This is to inform all the employees of NYKS that as per the Rule 18 of Central Civil Services (Conduct) Rule, 1964, a Govt. employee has to submit his/her annual Immovable Property Return of the previous year by 31st January of the following year.

Therefore All State Directors are requested to collect IPRs (In original) for the calendar year 2022 (i.e. from 1st January, 2022 to 31" December, 2022) from the employees under their control and after compiling the same, the original IPRs should be forwarded to the Hqrs in a single covering letter for records.

It may be noted that the last date for submission of IPR-2022 by each employees is 31.01.2023. All employees are also directed to forward a copy of their IPR-2022 by email on ddpersonnel@gmail.com with a copy to their SD's email also, for proof of submission, while the original IPR-2022 is to be submitted to their concerned State Director.

Adhering to the time-line is mandatory failing which necessary action may be initiated against the concerned employee as per extant rule and denial of Vigilance Clearance as it is the responsibility of individual employee to ensure timely submission of his/her annual Immovable Property Return.

All State Directors of NYKS are hereby requested to forward all the original compiled IPRs-2022 received from the employees under their jurisdiction along with the date of submission of the receipt of IPRs to NYKS, Hqrs, New Delhi on or before 10th Feb. 2023.

Accordingly all the State Directors are requested to circulate the same to all employees under their jurisdiction for their necessary action.

The format for submission of annual Immovable Property Return-2022 is annexed herewith for reference.
