## OFFICE MEMORANDUM

**Sub: Bringing Political or other influence to superior authority for furtherance of interest in respect of their service matters by employees - reg.**

Sir/Madam,

This is continuation to NYKS Hqrs letter no. 11040/NYKS/PERS:circular/196/2020 dated 04.02.2020 whereby it was communicated that few employees of Nehru Yuva Kendra Sangathan are pressuring the administration through outside influence regarding their transfer and other service matters.

It is again reiterated that Rule 20 of CCS (Conduct) Rules, 1964 has laid down that "No Government servant shall bring or attempt to bring any political or other influence to bear upon any superior authority to further his interest in respect of matters pertaining to his service under the Government".

It is believed that any high dignitary or Member of Parliament normally sponsors the case of an individual Government servant only when the VIP has been approached or pressed to do so. If, therefore, any reference is received on behalf of a Government Servant from a dignitary/Member of Parliament, it would be assumed that it has been taken up only at the instance of the Government Servant and action will be taken against him/her for violation of Rule 20 and instructions issued there under

It is therefore, requested to all employees to refrain from making any such efforts.

Violation of above rule and instructions would invite disciplinary action against the employee concerned as per rules.

This issues with the approval of the Competent Authority.
