Sub: Focus on the Activities of EBSB during the organization of National Integration Camp-reg.

- This has reference to NYKS HQ Letter No. NYKS/NPYAD-NIC/2019-20/97 dated 31st October2019 whereby it was conveyed to integrate the activities of EBSB with the National Integration Camp.
- 2. It is reiterated to ensure that the requisite information must be conveyed to the concerned DYCs for appropriate initiatives at their level. It may please be noted that EBSB is priority programme of Govt. of India and therefore, execution of various activities are being monitored by higher authorities on a regular basis.
- 3. It is reiterated that while organizing NIC, activities mentioned in the letter dated 31st Oct.2019 must be organized without fail and focus should be given on paired state teams. This is the top most priority. For ready reference the copy of the earlier letter dated 31st October2019 is enclosed.
- 4. With a view to give quality input to the activities of EBSB, NYKS is also collaborating with Ministry of Culture, Govt. of India. In this regard, you must have already been contacted by Zonal Culture Centres of Ministry of Culture, Govt. of India or will be contacted by them shortly. As a part of this collaboration, ZCCs will organize some activities focusing on EBSB during NIC. While doing this, following points may be adhered to:
 - That NYKS will not incur any amount on the boarding lodging, travelling, organizational or any other items related with the members of ZCC Contingent.
 - That NYK will only provide stage to the contingent of ZCCs as per the availability of time in the schedule(as decided by the DYC/SD in consultation with the representatives of ZCCs).
