1. - D. The firms must have at least Five years experience of internal Audit of 100% aided societies registered under the society's Act 1860 and fully funded by the central /State government.
- E. The firms must have at least 5 year of experience of compilation of accounts of such societies
- F. The Firm should have at least two fellows Members (FCA) as partners.
- G. The firms will be appointed on the year to year basis with maximum periods of three years

### 4: Selection Procedure

## Two Bid System as per GFR 2017 will be followed:

The Technical Bid and the financial bid should be sealed in separate covers duly super scribed and both these sealed covers are to be put in a bigger cover which should also be sealed and duly super scribed. The technical bids will be opened at the first instance and evaluated by a evaluation committee. At the second stage financial bids of only the technically qualified offers will be opened for further evaluation and ranking before selection.

Least Cost System will be sued for evaluation of financial bids and there will be no weightage for Technical score in the final evaluation and the responsive technically qualified proposal with the lowest evaluated cost will be selected.

Late bids (i.e. bids received after the specified date and item for receipt of bids) will not be considered.
